# From the President

While the recent rain has been a welcome relief, we know this is only the beginning of managing what has been the most severe statewide drought in 100 years.

During this time, South Australian dairy farmers have been able to access fodder freight subsidies through the State Government, PIRSA and SADA. All eligible Round One applications have now been assessed, with final payments due this week. Round Two reporting and acquittals are almost

complete, and payments are expected to follow within the next fortnight.

This will mark the final subsidy for dairy farmers, as funding has now been fully allocated. The additional \$1 million announced last week will be directed to other regions still experiencing ongoing drought conditions. On behalf of SADA, I thank the State Government, PIRSA and Minister Clare Scriven for their support and recognition of the complex challenges facing our industry. Looking ahead, the SADA team has been preparing a comprehensive survey to inform our Election Ask. I encourage all members to take five minutes to complete it—your input is critical in helping us build a strong, collaborative paper that represents the voice of dairy in South Australia.

# **Effluent Management Plans Update**

Recently, several dairy farmers have received correspondence from the EPA regarding their effluent management systems. While the circumstances differ from farm to farm, a number of common themes have emerged that are worth noting.

In several cases, systems that were originally approved by the EPA are now being revisited, with new requirements being imposed. This includes calls for six months' storage capacity or system rebuilds that go far beyond what was initially approved.

Some key issues raised include:

- Systems approved by the EPA at the time are now being deemed undersized or inadequate.
- Design features have been incorrectly interpreted as faults, such as subsidence where no structural issue exists.
- Spreading of effluent during the storage period has been flagged as a concern, despite being permissible under the right weather conditions and supported by the effluent design Toolkit.
- Systems designed for year-round application, including during winter, are being challenged despite their suitability for such use.

Overall, the central issue appears to be that the concept of a "storage period" is being treated as absolute, rather than as a flexible guideline intended to ensure responsible effluent management. This approach does not align with the intent of the Toolkit on which these requirements are based.

SADA continues to monitor these developments closely and will advocate on behalf of members to ensure practical, fair, and consistent regulation.

# **Animal Welfare** of South Australia Act Update

In 2022, the State Government committed to reviewing the Animal Welfare Act <u>1985</u> to ensure the laws governing animal treatment reflect community expectations. Earlier this year, the Animal Welfare Bill 2025 passed through Parliament and is now the Animal Welfare Act 2025. While the Act has been passed, it has not yet come into force—the Animal Welfare Act 1985 remains the legislation currently applied in day-to-day matters. The new Act requires a fresh set of regulations to support it. Work is well underway on developing these draft regulations. Once they are ready, the Department for Environment and Water (DEW) will run a consultation process to seek industry and community feedback.

## Q fever warning ahead



of spring spike. People

who work with or near livestock are

being warned of the dangers of Q fever ahead of the spring and summer peak. Q fever is an infectious disease caused by the bacteria Coxiella burnetii and is transmitted to humans from indirect or direct contact with animals, predominantly in regional areas.

There have been 18 cases of Q fever reported to SA Health this year to date. There were 23 cases reported in 2024, and



21 cases in 2023.

#### Positive Outcome on DILA Re-

structure Issue Home Affairs has confirmed a flexible approach to Dairy Industry Labour Agreement (DILA) cases where businesses restructure and change ABN. Employers must re-nominate staff, but existing visa holders will not need new visas, and permanent residency eligibility will not be reset if employees remain in the same role. This decision provides much-needed clarity for dairy businesses.

# Bendigo Bank Agribusiness The value of Australian

agricultural exports surged \$5 billion (+7 per cent) to \$77.2 billion in 2024/25, the second highest export year on record as livestock sector exports lifted to all-time highs. While cattle industry exports grew significantly, South Australia recorded the largest decline of all states with a \$982.4

# RIC loans available to help improve cash flow in tough financial times

RIC (Regional Investment Corporation) is the Australian Government farm business lender providing low-interest loans to farmers in South Australia and nationally.

RIC loans are for good farmers in tough financial times due to circumstances outside their control to prepare for, manage through and recover from drought or other events.

The loans can be used to restructure existing debt to reduce loan repayments and improve cash flow to get back on their feet, or new debt for capital expenditure.

Loans are available for up to \$2 million with the first five

years interest only, followed by principal and interest repayments for the remainder of the 10-year loan term. At least 50 per cent of a farmer's total debt must stay with their commercial lender.

In the seven years since RIC began, loans valued at over \$208 million have been settled for dairy farmers nationally, as at 31 August 2025.
